The Foundation is a not-for-profit corporation incorporated in accordance with the laws of the State of Idaho and is managed by a volunteer Board of Directors. Under the Idaho State Board of Education's administrative rules the Foundation must be independent of, and cannot be controlled by, Idaho State University (the University). Operating and services agreements between the Foundation and the University define the relationship between the two entities in accordance with the State Board of Education's rules. The mission of the Foundation is accomplished by focusing on three primary service areas. (Continued on Schedule O)

These assets were reported on the balance sheet in Funds Held for Others. The ISUF is the trustee for a CRT that has one beneficiary outside the ISUF.
