- I. President – President Watts absent.

- II. SAB Director – SAB Director Morgan shared that this weekend is the SAB Abyss Halloween Party event is this Friday, October 13th at 8 pm. The next two events this month are, Bengal Wednesday on October 18th and the Bootacualr Event on Wednesday October 25th. Director Morgan also shared that SAB is working on implementing a card reader system for students that are free to events to ensure that only students who pay the student fees are getting into these events for free.

- III. Vice President – Vice President Reynolds reported that he met with Craig Chatriand and the team developing the engagement app. The engagement app is being shared with the University's IT department to work out any kinks or security issues.
