9) Legislative Session update - President Wagner and Ryan Sargent via ZOOM - 19:15

- a) Anti-DEI bill update
 - i) Currently in draft form and written by Sen. Ben Toews (R-Cd'A), a member of the DEI Taskforce established by the Speaker of the House and the Senate Pro Tem. The taskforce was asked to look into DEI initiatives that were happening in colleges/universities
 - (1) This committee had no clear understanding of their role. Sen. Toews drafted a bill to address a 'perceived' problem in regards to DEI
 - ii) Pres. Wagner and Ryan Sargent are working with SBOE to address this
 - iii) ISU is well-positioned politically with good relationships with members of the Legislature
- b) Another proposed bill (still in a work group) reaches into curriculum including censorship of what words can be said in classes
- c) Unknown what problem the legislature has with this vague and contradictory policy
- d) Pres. Wagner was the only university president that sat down with the legislature regarding this issue, his concerns were addressed
- e) Ryan Sargent is at the Capitol full-time now during the legislative session
- f) Life Science Bld. \$14 mill (gov. office and the Building Fund Advisory Council recommended, JFAC will follow)



- g) CEC Gov. office recommended 5% increase for state employees JFAC still considering
 i) Budget projections are not in yet, many ambitious projects to be funded
- h) Higher Ed week went very well for ISU
- i) Title IX moved under the Pres. Office and Senate is happy
- j) State of University Address tomorrow! (Challenging things will be addressed)

10) Budget report - Jen Steele - 56:30

- a) Multi-year deficit reduction plan
 - i) Started out the fiscal year with \$6.5mil deficit in central funds; additional \$3mil will be cut due to increased enrollment and tuition revenue and continued conservative spending
- b) Fiscal year 2026 will present a balanced budget one year ahead of schedule
 - i) Maintain enrollment gains
 - ii) Proposing tuition increases
 - iii) Governor's budget recommendation includes \$900,000 in operational capacity enhancement
 - iv) Added \$1mil increase for enrollment workload adjustment (state funding formula)
 - v) Merit and across the board raises (CEC)
- c) Budget Optimization Initiatives
 - i) Four more projects to be implemented with the University Administration Group reviewing data
- d) OAR core personnel model has been implemented
- e) BAG will continue meeting moving toward maintenance and assessment, data sets and decision support
- f) Budget Town Hall by ZOOM Mar. 13, opportunity to submit questions in advance
